INSTRUCTIONS FOR USE: PHOBI F&F IS A ONE-SHOT AEROSOL. ONCE ACTIVATED, THE AEROSOL WILL EMPTY ENTIRELY. RESPECT THE INSTRUCTIONS FOR USE AS FOLLOWS: EVACUATE PEOPLE, ANIMALS, PETS (INCLUDING TERRARIUMS AND AQUARIUMS), REMOVE ANY FOODSTUFFS AND TIGHTLY CLOSE DOORS AND WINDOWS. ONCE THE AEROSOL IS ACTIVATED PLACE ON A NON-SENSITIVE SURFACE. IMMEDIATELY LEAVE THE PREMISES AND ALLOW THE PRODUCT AT LEAST 2 HOURS TO ACT AND CONTROL THE PESTS. VENTILATE THE TREATED ROOM THOROUGHLY BEFORE ENTERING. INSECTS ARE KNOCKED-DOWN INSTANTANEOUSLY.
