DESCRIPTION

IMIDASECT is a ready to use insecticidal bait for the control of cockroaches.

Target insects:

Cockroaches (*Blatella germanica*, *Blattella orientalis*, *Supella longipalpa*, *Periplaneta americana*)

Mode of action:

The active ingredient, imidacloprid, acts by binding to the insect's neurons. This binding causes a disturbance in the transmission of nerve impulses which is lethal to the target insect.

Cockroaches are attracted by nutritional ingredients in this product. Cockroaches come into contact with the gel and spread it around as they move contaminating their peers. Poisoning occurs through contact and ingestion. Death of all individuals occurs within ten days, regardless of the development stage (larvae, juveniles, adults).

Under normal conditions, gel drops remain active and palatable for about 2 months.

Use instructions:

Before treatment, remove all natural sources of food for cockroaches (waste, food scraps, etc.) from the infested area to encourage the ingestion of the gel.

Apply the gel to identified areas but also between food sources as well as warm (<50 °C) and humid sheltered areas (corners, cracks, crevices, air ducts, behind baseboards and appliances, along pipes, close to water points, etc.).

During inspections check the treated area and, if necessary, replace the gel used as cockroaches leave secretions and faeces to attract conspecifics.

The gel can be applied locally without interrupting any activity in the treated local.

Intended uses: IMIDASECT is suitable for the pest control treatment in areas where insects congregate in domestic premises, caves, public buildings, commercial premises, (including hotels and kitchens), storage areas, industrial warehouses and vehicles used in transportation (including ships, planes and trains)

Remarks: Do not apply the gel near food, utensils and surfaces that come into contact with foodstuffs.

Do not apply the gel in areas where regular cleaning can move the bait to the surfaces that come into contact with foodstuffs. Do not apply the gel in areas regularly cleaned with water as the washing can remove the gel deposit.

Do not apply the gel in areas recently sprayed with insecticide. Do not spray insecticide on the gel.

The application of gel on the textile can cause discoloration.

Avoid excessive contamination of coveralls

Storage: KEEP IN A SAFE PLACE

Keep out of the reach of children.

Keep away from food drink and animal feedingsstuffs.

Keep the product in its original packaging. Under these conditions, IMIDASECT can be stored for 4 years.
