# USES AND APPLICATIONS

DELTASECT is an insecticide for professional use against crawling and flying insects such as; ants, cockroaches, flies, fleas, mosquitos, spiders and wasps. For use in public hygiene areas such as; in and around domestic premises, public and municipal buildings, food storage and processing areas and warehouses.

## DIRECTIONS FOR USE

It is advisable to apply DELTASECT through devices such as pumps or sprays. Apply the solution along the perimeter, corners and baseboards of the targeted area in addition to any cracks and crevices where insects may nest or hide.
